1. A \$200 non-refundable deposit is required when returning this application to enroll in a course.
2. There will be a missed driving session fee of \$60 because of no show, late cancelation, late arrival, or no permit.
3. All class requirements must be completed before scheduling Behind-The-Wheel.
4. **ALL FEES MUST BE PAID IN FULL PRIOR TO THE COMPLETION OF INSTRUCTION AND BEFORE ISSUANCE OF CERTIFICATES.** A refund of any fees or any part of fees will be provided upon request unless the school is capable or willing to perform its part of the contract within a reasonable time period.
5. Certificates will be issued on the day of completion.
6. The instruction provided does not guarantee that any student will pass the State license examination or that the student can secure a license, or that the student will be guaranteed employment upon completion of any course of instruction.
7. Students 17 years of age or under are required to complete a State approved Driver's Education Program prior to receiving a driver's license. Students 18 years of age and older may hold the learner's permit 60 days in lieu of completing driver training.
