TEENAGE DRIVER EDUCATION INFORMATION

The driver education program offered by Patriot Driving School is State Certified. We are certified for training persons under the age of 18 years, and are licensed by the Department of Motor Vehicles Commercial Driver Training Section.

The driver education program offered by Patriot Driving School consists of a minimum of thirty hours (30) of online instruction and seven (7) periods of behind-the-wheel instruction for students less than eighteen (18) years of age.

Students 17 years of age or under are required to complete a state approved driver's education program prior to receiving a driver's license. Students 18 years of age and older may hold the learner's permit for 60 days in lieu of completing driver training.
